



1973




Map 2. Percent Increase in Personal Income Per Capita, by States
1963 to 1973





1973




Percent Change in Ratio of State and Local Taxes to Personal Income, by States


State and Local Taxes Per Capita, by States

by States, 1963 to 1973




Local Taxes Per Capita, by States
1973




Map 8. Per Cent Increase in Local Taxes Per Capita, by States
1963 to 1973





1973


Map 10. Per Cent Increase in State Taxes Per Capita, by States
1963 to 1973





1973




Map 12. State Aid as a Per Cent of Local General Revenue, by States






Chart 5. Percent distribution of Gross National Product or Expenditure Components*, United States, 1929-74


